Sub: Scrutinizer's Report on the Postal Ballot process conducted through remote e-voting system in accordance with the provisions of Section 108 and 110 of the Companies Act, 2013 read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014.

Aurobindo Pharma Limited (the "Company") sought the approval of the Shareholders by way of Postal Ballot for the Special Resolution as set out in the Notice dated February 9, 2026.

I submit my report as under:

- 1.As per General Circular No. 14/2020 dated April 8, 2020, No. 17/2020 dated April 13, 2020, No. 20/2020 dated May 5, 2020, No. 22/2020 dated June 15, 2020, No. 33/2020 dated September 28, 2020, No. 39/2020 dated December 31, 2020, No. 02/2021 dated January 13, 2021, No. 10/2021 dated June 23, 2021, No.20/2021 dated December 8, 2021, No. 03/2022 dated May 5, 2022 ,No. 11/2022 dated December 28, 2022, No.09/2023 dated September 25, 2023, No. 09/2024 dated September 19, 2024 and No.03/2025 dated September 22, 2025 issued by the Ministry of Corporate Affairs ("MCA Circulars") and other applicable provisions, including any statutory modification or re-enactment thereof for the time being in force and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company has sought the approval of the Shareholders by way of Postal Ballot by voting through electronic means (remote e-voting) for the Special Resolution as set out in the Notice dated February 9, 2026 which was sent on February 24, 2026 by email only to those Members who have registered their e-mail addresses with the Company or Depository Participant / Depository / Kfin Technologies Limited, the Company's Registrar & Transfer Agent.
- 2.The Board of Directors of the Company at its Meeting held on February 9, 2026 appointed me as a 'Scrutinizer' for conducting the Postal Ballot voting process in accordance with the law.
- 3.As per the MCA Circulars, physical copies of the Notice, Postal Ballot Forms and Pre-paid Business Reply Envelopes were not dispatched to the Members for this Postal Ballot. Accordingly, the communication of the 'Assent' or 'Dissent' of the Members had taken place through remote e-voting system only.



4. The Members of the Company holding Equity Shares as on the "cut-off date" i.e. February 20, 2026 were entitled to vote on the proposed resolution as set out in the Postal Ballot Notice dated February 9, 2026, through remote e-voting only.
5. The Company has published an advertisement in Business Standard (English daily) and Nava Telangana (Telugu daily) on February 25, 2026, informing about mailing of Postal Ballot Notice and also specifying thereon the matters with regard to e-voting.
6. The Company has appointed Kfin Technologies Limited for facilitating e-voting to enable the Members to cast their votes electronically. The remote e-voting period commenced on February 27, 2026 (9.00 a.m.) and ended on March 28, 2026 (5.00 p.m.).
7. The votes cast through electronic means by Members were unblocked on March 28, 2026 after 5:00 PM. The report on the Members e-voting was downloaded thereafter.
8. Particulars of all the Votes cast through electronic means as recorded through online platform provided by Kfin Technologies Limited as entered in the registers separately maintained for this purpose have been considered for this report.
