**Scrutinizer's Report on Voting through E-voting for Postal Ballot in terms of Section 108 and 110 of the Companies Act, 2013 and Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014.**

- 1) I, **Vipin Kumar Chhawchhriya** proprietor of **M/s VC & Associates**, Practicing Company Secretary, Indore having Membership Number A39361 and Certificate of Practice 14655, have been appointed as the scrutinizer by the Board of Directors of M/s. **Parin Enterprises Limited (Formerly Known as Parin Furniture Limited)** ("the Company") at their meeting held on 21st April, 2026 for votes cast through electronic means for the postal ballot process in respect of the resolution as set out in the postal ballot notice dated 21st April, 2026 ("Notice").
- 2) Members approval was sought for Resolution as stated in the Postal Ballot Notice and agenda item details are also mentioned in the Postal ballot Result column of this report.
- 3) Pursuant to Section 108 and Section 110 of the Companies Act, 2013 ("Act") and other applicable provisions of the Act and Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014, General Circular No. 09/2023 dated September 25<sup>th</sup>, 2023 and 09/2024 dated September 19<sup>th</sup>, 2024 and other relevant circulars issued by Ministry of Corporate Affairs from time to time ("MCA Circulars"), Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Secretarial Standard on General Meetings issued by the Institute of Company Secretaries of India ("SS-2") and any other applicable law, rules, circular, notification (including any

statutory modification(s) or re-enactment(s) thereof, for the time being in force), the Resolution as set out in the notice was placed for approval of members of the Company through remote e-voting only.

- 4) The Company has confirmed that the electronic copies of the Notice and the Explanatory Statement, along with the process for remote e-voting in terms of MCA Circulars, were sent on 21<sup>st</sup> April, 2026, to those members whose email addresses were registered with the Depositories, the Company, and/or Kfin Technology Limited ("RTA") as of the cut-off date, 17<sup>th</sup> April, 2026, based on the Register of Members/Register of Beneficial Owners maintained by National Securities Depository Limited ("NSDL") and Central Depository Services (India) Limited ("CDSL").
- 5) The Company has appointed **Kfin Technology Limited** ("Kfin"), as the agency for providing remote e-voting facility to the members of the Company.
- 6) Members were required to communicate their assent or dissent only through remote e-voting system in terms of said MCA Circulars.
- 7) The remote e-voting period commenced on 25<sup>th</sup> April, 2026 at 9:00 a.m. (IST) and ended on 24<sup>th</sup> May, 2026 at 5:00 p.m. (IST).
- 8) Accordingly, the votes cast through remote e-voting were taken into account and at the end of the remote e-voting period on 24<sup>th</sup> May, 2026 at 5:00 p.m. (IST), the remote e-voting module was thereafter disabled for voting by **Kfin Technology Limited** ("Kfin") The remote e-voting summary statement was thereafter downloaded from E-voting details from Kfin E-voting platform.
- 9) The Result of Postal ballot through e-voting is as under:

**Item No. 1: Special Resolution:** To consider and approve proposal for migration of the company from SME Board to Main Board of National Stock Exchange of India.
