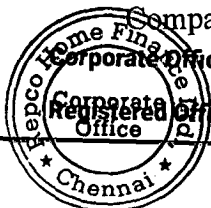

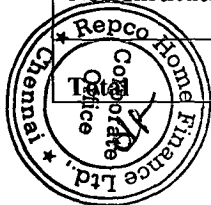

The Notice was also placed on the website of the Company and that of the agency, i.e., KFin Technologies Private Limited (formerly known as Karvy Fintech Private Limited) (referred to as "KFin").
