Sub: Report on the E-voting conducted through Postal Ballot

Dear Sir,

1. Appointment as Scrutinizer:

The undersigned has been appointed as Scrutinizer for the e-voting through postal ballot conducted by the Company under the provisions of Section 110 read with Section 108 and other applicable provisions, if any, of the Companies Act, 2013, ('Act') read with Rule(s) 20 and 22 of the Companies (Management and Administration) Rules, 2014, ('Rules'), Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, ('Listing Regulations') [including any statutory modification(s), amendment(s) or re-enactment(s) thereof, for the time being in force], General Circular Nos. 9/2024 dated September 19, 2024, 3/2022 dated May 5, 2022, 20/2021 dated December 8, 2021, 10/2021 dated June 23, 2021, 39/2020 dated December 31, 2020, 33/2020 dated September 28, 2020, 22/2020 dated June 15, 2020, 17/2020 dated April 13, 2020 and 14/2020 dated April 8, 2020 issued by the Ministry of Corporate Affairs ('MCA Circulars'), Secretarial Standard on General Meetings ('SS- 2') issued by the Institute of Company Secretaries of India. Our responsibility as Scrutinizer was to ensure that the postal ballot process (through e-voting) was conducted in a fair and transparent manner and to submit our report on the basis of the electronic data generated from the e-voting system.

2. Voting through Postal Ballot:

- 2.1 The management of the Company is responsible to ensure the compliance with the requirements of the Act, and the Rules made thereunder, the MCA Circulars, SS-2 and the Listing Regulations, relating to voting through postal ballot (e-voting) on the resolution contained in the Postal Ballot Notice dated January 16, 2025 ('Notice').
- 2.2 In compliance with the MCA Circulars, Sections 108 and 110 of the Act and the Rules made thereunder and Regulation 44 of the Listing Regulations, the Company provided remote e-voting facility to seek the approval of members of the Company for the resolution contained in the Notice.
- 2.3 In terms of the MCA Circulars, no physical ballot forms were dispatched by the Company and the votes were cast using remote e-voting facility only.

3. Cut-off Date:

The voting rights were reckoned as on Friday, February 7, 2025 being the cut-off date for the purpose of deciding the entitlement of members to vote through the postal ballot.

4. E-voting Process:

- 4.1 The Company appointed KFin Technologies Limited for providing e-voting facility through Postal Ballot.

4.2 The e-voting period commenced on Tuesday, February 11, 2025 at 09:00 A.M. (IST) and ended on Wednesday, March 12, 2025 at 5:00 P.M. (IST).

5. Counting of Votes:

5.1 After the end of e-voting cycle, the votes cast through postal ballot (e-voting) were unblocked by the undersigned.

5.2 The votes abstained are not considered in the voting result furnished hereinafter.
