We are pleased to present the report on the Postal Ballot through remote e-voting conducted by Shilpa Medicare Limited ("the Company") seeking the consent of its Members for the Ordinary Resolutions as contained in the Notice of Postal Ballot dated Saturday, January 06, 2024.

I, Ajay Naga Chowdary Vemuri, Partner, VCAN & Associates, Practicing Company Secretaries, have been appointed as the Scrutinizer by the Board of Directors of the Company pursuant to Section 108, 110 of the Companies Act, 2013("the Act") and read with rules 20 and 22 of the Companies (Management and Administration) Rules, 2014 ("Management Rules") for the purpose of scrutinising the postal ballot through e-voting in respect of the below-stated resolution as proposed in the Postal Ballot Notice dated Saturday, January 06, 2024, and I submit my report as under:

### 1. Management Responsibility:

The management is responsible for ensuring compliance under the Act, Management Rules, General Circulars Nos. 14/2020, 17/2020, 22/2020, 33/2020, 39/2020, 10/2021, 20/2021, 03/2022 and 11/2022 dated April 8, 2020, April 13, 2020, June 15, 2020, September 28, 2020, December 31, 2020, June 23, 2021, December 8, 2021, May 5, 2022, and December 28, 2022, respectively issued by the Ministry of Corporate Affairs ("the MCA Circulars"), Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 as amended ('SEBI Listing Regulations'), Secretarial Standard on General Meetings ('SS-2') issued by the Institute of Company Secretaries of India and any other applicable law, rules and regulations(including any statutory modification(s) or re-enactment(s) thereof, for the time being in force) in respect of postal ballot through remote e-voting.

### 2. Scrutiniser's Responsibility:

My responsibility as the scrutiniser is restricted to scrutinise the e-voting process, in a fair and transparent manner and to prepare scrutinisers report of the votes cast in favour and/or against the resolution stated in the postal ballot notice, based on the reports generated from the e-voting system provided by KFin Technologies Limited ("KFinTech"), which was engaged by the Company for conducting voting through electronic means.

**3. Cut-Off Date:**

The shareholders of the Company holding shares as of the cut-off date, i.e. Friday, December 29, 2023, were entitled to vote on the resolution as contained in the postal ballot notice.

**4. Postal Ballot Process:**

- a. In terms of the Postal Ballot Notice, the e-voting commenced on Sunday, January 07, 2024, 9:00 a.m. to Monday, February 05, 2024, 05.00 p.m., and the e-voting module was blocked by KFinTech thereafter.
- b. The votes cast under e-voting were thereafter unblocked and downloaded on Tuesday, February 06, 2024, at 10:47 AM IST from the portal of KFinTech, and as witnessed by two witnesses, who are not in employment of the Company and/or the KFinTech.
- c. I have Scrutinised and reviewed the remote e-voting based on the data downloaded from the KfinTech e-voting system, at <https://evoting.kfintech.com>.

**5. Postal Ballot Result:**

After ascertaining the votes cast by remote e-voting, I hereby submit the results as an **Annexure- I** to this report. Based on combined results, we report that all the resolutions as per the Postal Ballot Notice dated Saturday, January 06, 2024, stand passed with the requisite majority.
