In compliance with Regulation 44 of the SEBI Listing Regulations and pursuant to the provisions of Sections 108 and 110 of the Act read with the rules framed thereunder and the MCA Circulars, the manner of voting on the proposed resolution is restricted only to e-voting i.e., by casting votes electronically instead of submitting postal ballot forms. 1. The relative Explanatory Statement pursuant to Section 102 of the Act read with the Rules, setting out all material facts relating to the Resolution mentioned in this Notice is attached. The information required to be furnished under Regulation 36(3) of SEBI Listing Regulations and SS-2, in respect of persons seeking appointment / re-appointment as Director are also annexed.
2. In accordance with the MCA Circulars, this Notice is being sent only by electronic mode to those members whose names appear on the Register of Members / List of Beneficial Owners as on Friday, 10th March, 2023 (“**Cut-Off Date**”) received from the Depositories and whose e-mail address is registered with the Company / Depositories / RTA. Physical copies of the Notice along with postal ballot forms and pre-paid business reply envelopes are not being sent to members for this Postal Ballot.
3. Only those Members whose names are appearing in the Register of Members / List of Beneficial Owners as on the Cut-Off Date shall be eligible to cast their votes through postal ballot by remote e-voting. A person who is not a Member on the Cut-Off Date should treat this Notice for information purposes only.
4. In compliance with the MCA Circulars, the Notice and instructions for e-voting are being sent through electronic mode to those members whose email addresses are registered with the Company / depository participant(s).
5. It is however, clarified that all Members of the Company as on the Cut-Off Date (including those Members who may not have received this Notice due to non-registration of their e-mail addresses with the Company / RTA / Depositories) shall be entitled to vote in relation to the aforementioned Resolution in accordance with the process specified in this Notice.

Appointment of Shri Vipul Mitra, IAS (DIN: 03108280) as a Director and Chairman of the Company:

The Government of Gujarat has vide Notification No. AIS/35.2023/08/G dated 31st January, 2023 appointed Shri Vipul Mitra, IAS (DIN: 03108280), as a Director and Chairman of the Company.

Pursuant to the requirement of Regulation 17(1C) of SEBI (LODR) Regulations, 2015, the listed entity shall ensure that approval of shareholders for appointment of a person on the Board of Directors is taken at the next general meeting or within a time period of three months from the date of appointment, whichever is earlier. Shri Vipul Mitra, IAS (DIN: 03108280) is an officer of Indian Administrative Services belonging to 1986 batch and was last serving as the Additional Chief Secretary, Govt. of Gujarat (Panchayats, Rural Housing and Rural Development Department). He possesses a degree of B.A. (Hons. Economics), Masters in Personnel Management & Industrial Relations and LLM from Nottingham University UK.

In a career spanning 37 years, Shri Vipul Mitra has served in several key positions in the Government in various Departments such as Finance, Education, Ports & Transport, Rural Development, Tourism, Labour & Employment, Panchayat etc., besides a few others. As Principal Secretary (Tourism), he played an instrumental role in the Khushbu Gujarati Ki campaign, featuring Amitabh Bachchan under the visionary leadership of the then Hon'ble Chief Minister, Gujarat, and presently the Hon'ble Prime Minister, Shri Narendra Modi. The campaign catapulted Gujarat among the most popular tourist destinations in the country. He was also Dy. Chairman of Kandla Port Trust for 5 years, which at that time, was the largest Port in India.

He has also authored two English novels 'Pyramid of Virgin Dreams' (Rupa Publications) and 'The Dream Chasers' (Random house) which turned out to be the best sellers.
